I. Introduction

III. What personal data we collect and how we use it

- Registration and use information When you register to use our Services, we will collect Personal Data as necessary to offer
 and fulfil the Services you request. Depending on the Services you choose, we may require you to provide us with your
 name, postal address, telephone number, email address and identification information. We may require you to provide us
 with additional Personal Data as you use our Services.
- Information that you choose to provide us to obtain additional Services or specific online Services If you request or
 participate in an optional Site feature, or request enhanced Services or other elective functionality, we may collect additional
 information from you. We will provide you with a separate notice at the time of collection, if the use of that information
 differs from the uses disclosed in this privacy policy.
- Information about you from third-party sources We may obtain information from third-party sources, where permitted by law
- Other information we collect related to your use of our Sites or Services We may collect additional information from or about you when you communicate with us, contact our customer support teams or respond to a survey.

- Face Data / Biometric Information Some of our Services may capture face images from submitted documents and/or live
 face captures using a device camera. The app does not itself retain this data; it is securely transmitted to our backend
 systems, where it is processed to verify identity, confirm liveness, prevent fraud, and meet legal and regulatory
 requirements.
- Retention: Face data is not stored indefinitely. It is retained only for the period required to fulfil the relevant legal or
 regulatory obligation, or for the period agreed with the clients data protection officer. After this period, the data is securely
 and permanently deleted.
- Sharing: We do not share face data with unrelated third parties. Face data is stored securely using cloud hosting services
 (such as Amazon Web Services) under Xydus' direct control. These providers act only on our instructions and do not use or
 retain face data for their own purposes

What we do with the information we gather

- · We require this information to understand your needs, facilitate our services, and for the following reasons:
- We may process data about your use of our website and services. The usage data may include your IP address, geographical
 location, browser type and version, operating system, referral source, length of visit, page views and website navigation
 paths, as well as information about the timing, frequency and pattern of your service use. The source of the usage data is our
 analytics tracking system. This usage data may be processed for the purposes of analysing the use of the website and
 services. The legal basis for this processing is mainly monitoring and improving our website and services.
- We may process your account data. The account data may include your name and email address. The account data may be
 processed for the purposes of operating our website, providing our services, ensuring the security of our website and
 services, maintaining back-ups of our databases and communicating with you. The legal basis for this processing is the
 proper administration of our website and business
- We may process information contained in any enquiry you submit to us. The enquiry data may be processed to improve our services to you.
- · We may process information that you provide to us for the purpose of subscribing to our email notifications or newsletters.
- · Please do not supply any other person's personal data to us.
